Permission matter of Antarbharti Homoeopathic Medical College, Dabha, Nagpur, Sub: Maharashtra with 50 seats in UG (BHMS) course for the academic year 2022-23- reg.

Sir,

The Medical Assessment and Rating Board has received online application (Part-1) seeking permission for student intake in Under Graduate (BHMS) course with student intake of 50 seats for the academic year 2022-23.

- As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MA&RBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform that Part-1 Performa and all the relevant documents submitted by your college in were examined as per the existing regulations.
- On scrutiny and careful consideration of your documents and further observations of the Board, the following shortfalls to be addressed for granting permission for student intake in UG (BHMS) course for the academic year 2022-23:

A. TEACHING FACULTY:

i. Previous teaching experience of Lecturer of Dr. Zehra FaizanHaq, Associate Professor in Dept. of Pathology is not provided, ii. Previous teaching experience of Lecturer and Reader of Dr. Yashwant Shridhar Deshpande,

Professor in Dept. of Surgery is not provided.

- iii. Previous teaching experience of all Guest teachers are not provided except one Guest faculty namely Dr. Raja RamKrishna Rewatkar, Guest Associate Professor in Dept. of M.M. is not provided.
- B. MISCELLANEOUS: Form 16 for all staff from Traces Portal is not submitted for verification.
- C. HOSPITAL STAFF: Staff for Hospital catering is not available.
- After considering the provisions of NCH Act, 2020 and its relevant regulations, Antarbharti Homoeopathic Medical College, Dabha, Nagpur, Maharashtra with 50 seats in UG (BHMS) course for the academic year 2022-23. The Principal is directed to fulfill the deficiencies within one month and an undertaking from the controlling authority of the college may be submitted in this regard to the Medical Assessment Board within a period of one week.

- As per section no. 43 of the NCH Act 2020, vide letter no. Y-11011/4/2022-EP-III dated 14/10, 4. As per section no. 43 of the NCH Act 2020, vide letter no. 1-110 NEET only with qualifying no. - All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. It is further informed that, minimum 15% seats of permitted intake capacity of BHMS course shall be treated as All July 2 shall be treated as All India Quota. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed.
- The counselling for seats under All India quota shall be conducted by respective counselling Authority of State/UT Government as designated by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State / UT. 100% Under Graduate of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counselling of seats under All India Quota shall be conducted by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under.
- The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
