Application for letter of permission for functioning Antarbharti Homoeopathic Medical College (Dabha), Nagpur- 440023 for continuing BHMS course with intake capacity of 50 seats for the academic year 2024-2025 regarding.

Sir,

Antarbharti Homoeopathic Medical College is functional since 1974 has applied for permission for sanction of BHMS course with 50 seats for the academic year 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls

1. Hospital Details

IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation and made available in Medical Record Room for academic purpose of students and follow up of patients

Considering the above observations and facilities available, MARBH has decided to issue Conditional permission to Antarbharti Homoeopathic Medical College (Dabha), Nagpur-440023 for continuing BHMS course with intake capacity of 50 seats for the academic year 2024-2025.

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

It is further to mention that all admissions shall be made for NEET /AIPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats ofthe permitted intake capacity of 50 UG seats shall be treated as All India Quota. Thecounseling for seats under All India Quota shall be conducted by respective counseling authority of State/UT Govt. as designated by Central Government/NCISM/NCH for the A.Y. 2024-25 and counselingfor the remaining 85% seats or as the case may be, shall be conducted by the concerned CounselingAuthority of that State/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homocopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
